YTS Business Longitudinal Raw Data

YTS (YourEconomy Time Series) assembles one database from 20 annual snapshots following U.S. businesses at their unique location from 1997-2016. BDRC offers **two (2)** tiers from the YTS database you can discover online:

DIRECT YTS DATABASE ACCESS

Access our database (DDaTSL) directly, query and download data instantly based on your license. U.S. and state static regions will also be available to download. Data license is included.

Annual fee to access DDaTSL: \$1,500

*Additional **\$1,500** fee for Economic Development Organizations (EDO) outside of Wisconsin system

Tier 1 - Custom Records

Up to 50,000 records: \$2,500

Up to 100,000 records: \$4,000

Up to 200,000 records: \$9,000

Tier 2 - Static Regions

About the Infogroup Data License

BDRC will broker the Infogroup license transaction so that you deal directly with us. All data license costs are reflected in the option costs above. The entire scope of the project (services and data license) will be summarized using a MOU coming from BDRC and the University of Wisconsin - Extension Division for Business and Entrepreneurship.

Term of license is one year.
