



YTS (Your-economy Time Series) Establishment Data

YTS (Your-economy Time Series) assembles one database from 21 annual snapshots following U.S. businesses at their unique location from 1997-2017. BDRC offers two (2) tiers from the YTS database which you can discover via DDaTSL (Data Discovery and Time Series Locator) online in a web browser, query and download data instantly based on your license.

Tier 1 - Custom Records

Custom records refers to data requests that are constructed for you by BDRC choosing establishments that meet your specific criteria from these options: NAICS, years in business, employment size, time period options (1997-2017), custom built regions, physical relocations (moves), local ownership, and type of startups (new or existing).

Because a scope for custom records must be defined, and resources required for assembly and delivery, subscriptions for static regions are discounted from custom pricing.

YTS Data License and Updates

Tier 1 Custom Records include a one-time delivery with a two year license for use of the data, and do not include updates. Tier 2 Static Regions also include a two-year license for use of the data, but are available with a one-year update option for all years and one additional new year at 50% of the original license fee.

The data license agreement will be handled by a simple MOU from the University of Wisconsin Extension Division for Business and Entrepreneurship. [Template Example](#).

Standard YTS Database packages do not include *business contact* information. You can purchase the latest contact information for any business and receive current info: company name, address, phone, owner or officer, and management members if available.

- Up to 5,000: \$.15 cents each
